Although he was born in Earlsferry father and mother and rest of family moved to Glasgow in 1909/11. His father set up a golf club making business both in Earlsferry and Glasgow but he was principally known for the Crowley Sports Emporium in Gordon Street in Glasgow – it was probably one of the first genuine sports shops, although golf was its main concern and it continued well into 1970s. It is probably a pub now.

Jack became involved in the business along with his father. They continued the Elie/Earlsferry connection by having one of the "huts" beside the golf course along with Forrester (earlier) Reekie, Scott and eventually Ballantine.

Jack had a most unfortunate first marriage to Ann Stewart from St. Andrews, whose father was a golf club making. He married her in 1927 but she died tragically that year during childbirth and the child was stillborn. He remarried in London, Marion Brown Whitelaw in 1929.

He took over the business from his father in 1933 and the business continued after his death in 1966 which was shortly after his second wife's death in September 1966. He and his family still retained a foothold in Earlsferry having acquired Ravenscraig from George Forrester Executors.

CHARGE UNDER ACT OF JAMES VI.

CASE AT CUPAR.

A charge under an old Scottish statute was brought at Cupar Sheriff Court on Tuesday, when it was alleged that John Christopher Crowley, golf club manufacturer, 9 Stratton Drive, Giffnock, Glasgow, did, on August 17, at Carnbee Reservoir, Fife, "it being a stank or lock within the meaning of the Act of 19 James VI., attempt to steal trout or other fish." It was stated that he was liable to a fine of forty pounds Scots.

An agent, on accused's behalf, pleaded guilty. Accused, he said, had been looking for a place to fish and after making inquiries had gone to Carnbee Reservoir. No one was able to tell him whether fishing was forbidden there or not, and he thought that the custom in the West of Scotland of paying on the spot would be carried out. He had no intention of fishing without making payment. The owner appeared on the scene, and accused apologised for the liberty he had taken.

Hon. Sheriff Grosset imposed a fine of £1.

As a last anecdote let us look at the newspapers of 1937, when he fell foul of the law although it is understandable if he pled that he did not remember the statute of James VI!
